Local author adds depth to villains in new novella

Izmaylov publishes book with help of Salman Rushdie

ALPHARETTA, Ga. - Michelle Izmaylov was longing to find her own justification between hero and villain and ultimately decided to write and publish "Rico-

That justification of a hero and a villain has been a question that has consumed Izmaylov for many

years. She rarely found literature that examined the core question of how a villain justifies his or her actions, and Izmaylov decided to leave her mark on the littlediscussed subject.

During her sophomore year at Emory University, Izmaylov conceived a 25-page short story in a creative writing class but she later decided to expand it into a novella.

Izmaylov, now a medical student at Vanderbilt University, used the novella that became "Ricochet" to gain entrance to an elite writing program at Emory taught by the famous author, Salman Rushdie.

This class taught by Rushdie is extremely competitive. Only nine students were selected to be a part

Izmaylov said that getting into the program using the excerpt felt like a ringing endorsement for her to finish the book.

"As part of the competitive application process to study under Rushdie in his creative writing master class, I was required to submit several writing samples," said Izmaylov. "One of my samples was an excerpt from the original short story that has now given rise to 'Ricochet.' Since Rushdie selected me for his class, I guess this means the sample was a good

"Ricochet" took Izmaylov five months to write. She organized her senior year so she would have ample


time to finish the book. She said that there were many distractions that she decided to avoid, and she offered advice to aspiring writ-

"Personally, my biggest problem in writing is how easy it is to get distracted by the Internet.

She typically writes in places with no Inter-

net access so she is forced to work exclusively on her book

"It's also important to me to have at least a gen eral sense of where I'm going before starting a story. That way I don't completely derail and end up completely having to start over," she said. "Don't be afraid to experiment.

JCHS students build braille nature trail

JOHNS CREEK, Ga. — As part of Global Youth Service Day, a group of students from Johns Creek High School gathered April 27 at the Gwinnett Environmental and Heritage

Center to help design a braille nature trail for the visually impaired.

Led by 15-year-old Evan Barnard, who is vision impaired, the students took turns wearing blindfolds and writing down comments as they tested proposed sites for braille signage along the trail.

A braille nature trail is an outdoor nature trail with

special features that allow the trail to be used by the visually impaired.

The trails have guide ropes and posts so visitors can run their hands along them to follow the trail, as well as informative signs about the trail in both braille and English print.

Adding these features to existing nature trails improves the accessibility of trails so that visually impaired people can experience and learn about nature. Barnard's goal is to build these trails in communities all over Georgia, and raise awareness of the need to provide increased access to the outdoors to those with disabilities

ties.
"Many of the students were surprised at how difficult it was to walk along the trail when they were blindfolded. But they also realized how the interesting trail features, such as touching bark from different trees and listening to birds, can be appreciated without seeing them," said Barnard. "They also realized how dif-


ficult it would be if they were visually impaired and wanted to go outside and enjoy nature. This is why we are building this trail - to increase access for the visually impaired to enjoy the outdoors."

Barnard first had the idea to create a braille nature trail when he was volunteering for the Nature Conservancy in Rome at the Marshall Forest's Big Pine Nature Trail, the state's only braille nature trail. Unfortunately, the trail had been vandalized and its braille signs stolen, so Barnard helped install new signs and repair the trail.

He began working with the Georgia Council of the Blind, and soon learned how much the visually impaired loved the opportunity to have a place where they could go outdoors and safely enjoy nature.

Barnard plans to create more braille nature trails in Georgia to increase access to more people and find funding for more potential trail locations.


